2. SUPPLY AND DELIVERY OF TRAFFIC OFFICERS AND FIRE FIGHTERS UNIFORM

Pre-qualification criteria:

- Only bidders who have a BBBEE status level 1 may respond to this bid.
- Only locally produced goods or services that meet the minimum threshold of 100% for local production and content as determined by dti will be considered for acceptance. Any tender that does not meet the minimum threshold is an unacceptable tender

Bidders are required to submit original and valid B-BBEE Status Level Verification Certificates or certified copies or sworn affidavit thereof together with their bids, to substantiate their B-BBEE rating claims. Failure to submit the proof of B-BBEE Certificate or sworn affidavit will result in forfeiting the points. **Valid Tax compliant status, Proof of registration on central supplier database and company registration certificate must be submitted together with the tender document.** Service Provider must be registered on Municipality's Database.
