Each tender shall be placed in sealed envelopes, endorsed with the Tender Number and PROJECT NAME, and be placed in the Tender Box at the Municipal Offices, 34 Voor Street, Utrecht, 2980 not later than 12h00 on 11 September 2023 (closing date), at which the tenders will be opened in public. Tenders are also to be submitted on the tender documentation provided by Municipality. Late, Electronic or faxed tenders will be not accepted.

No correspondence will be entered into with any tender regarding scores

obtained, reasons for no appointment, etc. **No late, telephonic, facsimile or e-mailed tenders will be accepted.**

The following tenderers who are registered with the CIDB, or are capable of being so registered prior to the evaluation of submissions are eligible to submit tenders:

- Contractors who have a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered for 4CE class of construction work; and
- Joint ventures are eligible to submit tenders provided that:
  - every member of the joint venture is registered with the CIDB;
  - the lead partner has a contractor grading designation in the 4 CE or Higher class of construction work; and
  - the combined contractor grading designation calculated in accordance with the construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for an 4CE class of construction work.
